Shuyuan Hong spoke at length about how improper needling can damage a patient and that the Body is a complex system. She indicated deep concern about Dry Needling being performed by Athletic Trainers.

Della Estrada similarly expressed concerns about Dry needling and spoke on Auricular Acupuncture.
