#### Status report from Board consultant on dry needling

Theresa Ulmer from the Aarons Company informed the Board of a stakeholder meeting being scheduled by the Arizona House of Representatives to address the dry needling issue. Ms. Ulmer explained the continuation bill regarding the Arizona State Board of Physical Therapy and outlined the timeline whereby the acupuncture profession will have an opportunity to share their concerns about dry needling as performed by physical therapists.

### Review and Adoption of 2014 Fees pursuant to A.R.S. §32-3927

Executive Director Gonzalez provided the Board with an overview of the fee schedule as presented.

The Board discussed the variance of fee schedules with other health professions.

### Preliminary discussion of Strategic Plan—2014

Chairman Rhodes shared his list of priorities for 2014 to include dry needling and the effort to protect the public. The Board would like to see this issue resolved in order to move forward on other issues facing the profession.

Another topic for future discussion is the practice of auricular acupuncture to include the role of the supervisor who is a licensed acupuncturist.

Chairman Rhodes raised the idea of a "code of ethics" and asked whether the Board should pursue such a code. Board Member Seitz advised the Board to move on this idea with caution, but sees the benefit of exploring this proposal.

# Letter from the Arizona State Board of Physical Therapy in response to Board inquiry of physical therapists using the phrase "certified in dry needling" in their advertisements.

The Arizona State Board of Physical Therapy at their December 17, 2013 board meeting discussed the Board's request for response. The Arizona State Board of Physical Therapy responded by sending a letter asking if the Board is requesting and advisory opinion from Arizona State Board of Physical Therapy regarding the appropriateness of Arizona licensed physical therapists using the phrase "certified in dry needling" in advertising.

The Board discussed the response from Arizona State Board of Physical Therapy and determined to proceed with its efforts at the legislature to resolve this matter.

Charles Brown, Executive Director from the Arizona State Board of Physical Therapy, explained the Board's response in greater detail.

## **Administrative Inquiries**

The Board reviewed the materials regarding Ms. Aeimee Diaz, L.AC. These materials include an explanation of Ms. Diaz's arrest for driving under the influence of alcohol. Ms. Diaz shared details of the charge and court sentence requirements. In addition, Ms. Diaz has sought out and is attending therapy.

Board Member Seitz asked if Ms. Diaz reported her first violation from seven years ago on her initial license application with the Arizona Acupuncture Board of Examiners. Ms. Diaz responded she did not report this incident.

Ms. Diaz did not report the March 23, 2013 incident until November 26, 2013 because her legal counsel instructed her to not report this incident until she was sentenced.

The Board discussed the lack of reporting the first charge on the initial application and on subsequent license renewal applications.

Board Member Rhodes moved to enter executive session to receive legal advice at 2:20 p.m. with Board Member Seitz providing a second. The motion carried by a vote: 5-1.
