## Complaint #2013-05—Kyseub Lee, L.AC.

Ms. Danielle Mampel addressed the Board regarding her allegation that Kyesub Lee, L.AC. sexually assaulted her on April 23, 2013 at Mr. Lee's office. The Board was provided with copies of Ms. Mampel's complaint, Chandler Police Department report on the incident and character reference letters provided in support of Ms. Mampel.

Ms. Mampel believes that Mr. Lee violated several sections of unprofessional conduct as found in A.R.S. 32-3901. These include 4 (b) (j) (l) (m) (s) (w). Ms. Mampel asked the Board to revoke Mr. Lee's acupuncture license. Ms. Mampel was seen for depression and she questioned why needles were inserted in the chest area during her treatment. She further questioned if a patient must disrobe for this treatment.

Board Member Martin provided a brief explanation of treatments and confirmed the point in the chest is appropriate.

Mr. Kyesub Lee stated the allegations are false and explained his treatment of Ms. Mampel.

Board Members asked Mr. Lee several questions regarding this treatment methods and how he handles treatments with female patients.

Mr. Lee stated if Ms. Mampel continues her effort against him, he will pursue other options to close the matter.

Ms. Mampel further explained some inappropriate touching and comments by Mr. Lee.

Member Martin moved to enter executive session to receive legal advice at 2:25 p.m. with Board Member Buechel providing a second. The motion carried by a vote: 6-0.

- Pursuant to Arizona Revised Statutes §32-3925 (B), license and certificate renewal notices for August 2013 licensees were prepared and sent. In addition, expired license and certificate letters for the month of May 2013 were sent.

## **Budget Information**

• The Legislature has approved the Governor's budget and the Board's funding requests have been approved.

## **Legislation**

Senate Bill 1037, introduced by Senator Nancy Barto, includes the Board's legislative recommendations as developed by the continuing education advisory and legislative advisory committees.

SB 1037 was approved by the Arizona State Senate on February 11, 2013 by a vote of 28 ayes and 1 nay and sent to the Arizona House of Representatives for action.

The Arizona House of Representatives Health and Rules have approved SB 1037 with unanimous votes. The Arizona House of Representatives Majority and Minority caucuses have approved the bill and the bill is awaiting committee of the whole action by the Arizona House of Representatives.

Further action on SB 1037 did not take place after the Legislature approved the state budget because they adjourned the legislative session on June 14, 2013 at 12:59 a.m.
