Professional Business

Report from the Legislative Advisory Committee

Committee Chair Patricia Martin provided the Board with a review of the legislative advisory committee's scope of work to include review of current statutes. In addition, the committee will review the recommendations of the continuing education and ethics advisory committee in order to determine if any legislation is required to address these recommendations.

The committee voted to forward the following proposals for board review and consideration.

- 1) Include compensation of board members to include all nine board members.
- 2) Remove preceptorship language
- 3) Display of license
- 4) Establish fee for license verifications
- 5) Establish in-active license status
- 6) Establish fee schedule for continuing education applications
- 7) Change to application so applicants must identify other licenses held when applying for acupuncture license

A number of other proposals will be addressed and considered at the next committee meeting scheduled for July 11, 2012.

Review and Discussion on Arizona's Sunrise and Sunset Process

Executive Director Gonzalez provided the Board a copy of the Legislature's Handbook on Arizona's Sunset and Sunrise Review process. The Board had the opportunity to examine the difference between these two processes and how each is used for different purposes.

Update on State Board of Physical Therapy action regarding dry needling complaints

A copy of the meeting minutes from Arizona State Board of Physical Therapy board meeting of May 22, 2012 were shared with the Board. The focus of this agenda item was for the Board to review the outcome of the complaints filed by the Arizona Society of Oriental Medicine and Acupuncture against licensed physical therapists that are practicing dry needling.

Board Members expressed an interest on the reason for dismissal since no reason(s) were provided in the Arizona State Board of Physical Therapy May 22, 2012 board meeting minutes.

Chairman Adelman moved to enter executive session to receive legal advice at 2:06 p.m. with Board Member Bennalley providing a second. The motion carried by unanimous vote: 7-0.
